## Corporate Affiliate Membership

Firms in the construction industry or those engaged in research, design, development, testing, manufacturing, distribution and/or training in the application of building and construction products as well as those involved in the supply and installation of furniture, fittings and equipment (FF+E) or systems for interior fitting out projects are eligible for the Corporate Affiliate category of membership. Corporate Affiliate members are allotted three representatives who generally enjoy the same benefits as all other categories of membership. Corporate Affiliate members joining the **AIA Hong Kong** are not required to join at the AIA National level. However, Corporate Affiliate members are eligible to join The American Architectural Foundation\* (AAF) if they so desire (though AAF is really more suitable to companies located in the U.S.A.). The cost of Corporate Affiliate membership in the **AIA Hong Kong** is HK\$8,000.00 per annum.

### **Corporate Affiliate members:**

- *May* serve in any capacity on Hong Kong chapter committees, attend meetings and conventions, and participate in scheduled activities and programs of the Institute.
- *May Not* vote (except on committees) or be appointed or elected as a chapter officer or serve in any policy-setting capacity.
- *May Not* print or permit to be printed, or in any way use the name, initials, emblem, seal, symbol or insignia of the Institute or component (i.e. local chapter).
- *May* identify their corporation or company as being a Corporate Affiliate Member of the AIA Hong Kong

### **Benefits of Corporate Affiliate Membership:**

- Attend interesting guided building tours, seminars and quarterly meetings featuring guest speakers.
- Networking - an opportunity to chat informally with local architects or other professionals and gain insight about the current issues affecting the industry.
- Receive Chapter newsletter, publications and unrestricted access to **AIA Hong Kong** web site.
- Only Corporate Affiliate members are eligible to host "brown bag" lunches or seminars.
- Good value for money: 3 delegates for \$8000 (and delegates may be changed yearly).
