

AIA Hong Kong Architecture Firm Award 2020

The AIA Hong Kong Architecture Firm Award is the highest honor that the Chapter can bestow on a firm for consistently producing distinguished architecture in the Chapter's region.

The Firm Award shall be given once every five years to recognize overall design achievement, professional leadership and service to society in work that exemplifies the highest standards of the architectural profession.

Eligibility

- AIA Member Firms based in Hong Kong for a period of not less than ten years. Past recipients of the Firm Award are not eligible
- AIA Member Firm must be at least 51% owned by US licensed architect AIA members in good standing

Submissions

A PowerPoint file in 1920x1080 format, maximum of 20 slides, which includes:

- Brief biography of firm principals residing in the Chapter's region and a history of the firm
- Statement summarizing the firm's contributions including social impact as 'Citizen Architects'
- List of the firm's design awards and other notable professional achievements
- Descriptive statements and images of the firm's work accompanied by at least three images for each selected project
- Authorized documentation to verify at least 51% ownership by US licensed architect AIA members in good standing

Criteria

- Demonstration of great depth and breadth in the body of work, having a cumulative effect on the profession of architecture and the community in the Chapter's region
- Producing work that is a product of a collaborative environment, consistently addressing the future of architecture while honoring its traditions
- Professional reputation among architects, designers, educators, and the public for the quality of their work
- Firm's policies that promote equality in the workplace and mentorship of young professionals

- HK\$1,750 for one firm's entry.
