



## Corporate Affiliate Membership

Corporate Affiliate Membership is available to companies or organizations involved in professions or businesses which are allied to the field of architecture such as construction, property development, education, journalism, manufacturing and related fields, as well as engineers, specialist consultants, landscape designers, urban planners, etc. Corporate Affiliate members are allotted three representatives who generally enjoy the same benefits as other categories of membership. Corporate Affiliate members joining **AIA Hong Kong** are not required to join at the AIA National level. However, Corporate Affiliate members are eligible to join The American Architectural Foundation (AAF) for companies located in the US. The cost of Corporate Affiliate membership in **AIA Hong Kong** is HK\$13,500.00 per annum. For three-year memberships, there is a special discounted rate of HK\$33,000.00.

### **Corporate Affiliate members:**

- May serve in any capacity on Hong Kong chapter committees, attend meetings and conventions, and participate in scheduled activities and programs of the Institute.
- May not vote (except on committees) or be appointed or elected as Chapter President or serve in any policy-setting capacity.
- May not print or permit to be printed or in any way use the name, initials, emblem, seal, symbol or insignia of the Institute or component (i.e. local chapter).
- May identify their corporation or company as being a Corporate Affiliate Member of the AIA Hong Kong Chapter.

### **Benefits of Corporate Affiliate Membership:**

- Attend guided building tours, seminars and quarterly meetings featuring prominent guest speakers, unique film screenings, and opportunities to engage with the local architectural community
- Networking – an opportunity to exchange informally with local architects or other professionals and gain insights about the current issues affecting the industry.
- Receive Chapter newsletter, publications and unrestricted access to AIA Hong Kong web site.
- Only Corporate Affiliate members are eligible to host “brown bag” technical seminars or other receptions with the AIA membership.
- 3 delegates may attend any event during the year. Delegates may be changed as needed.
- Receive publicity via chapter announcements, seminar hosting, event sponsorship, and social media.
