

The AIA Hong Kong Architecture Firm Award is the highest honor that the Chapter can bestow on a professional architectural practice for consistently producing distinguished architecture in the Chapter's region.

The Firm Award shall be open for nomination once every two years to recognize overall design achievement, professional leadership and service to society in work that exemplifies the highest standards of the architectural profession.

Eligibility

- AIA Member Firms based in Hong Kong for a period of not less than ten consecutive years. Past recipients of the Firm Award at Chapter, Region or National level are not eligible
- AIA Member Firm must be at least 50% owned by US licensed architect AIA members in good standing

Submissions

A PowerPoint file in 1920 x 1080 format, maximum of 40 slides, which includes:

- Brief biography of firm principals residing in the Chapter's region and a history of the firm
- Statement summarizing the firm's significant contributions to the profession and society
- List of the firm's design awards and other notable professional achievements
- Descriptive statements and images of the firm's work accompanied by at least 2-3 images for each selected project
- Authorized documentation to verify at least 50% ownership by US licensed architect AIA members in good standing

Criteria

- Demonstration of design excellence in the body of built design work and a positive influence or legacy on the profession of architecture as well as community in the Chapter's region
- Recipient of multiple AIA Honor or Merit Awards at Chapter, Region or National levels, as well as design awards from other peer professional institutes such as RIBA or HKIA, et al, and other nationally or internationally recognized organizations in the design or building industries
- Produced work that supports the values of the "AIA Framework of Design Excellence" as well as a collaborative firm culture that promotes equal opportunities in the workplace and mentorship of young professionals

Nomination

- Firm Award nominee shall be nominated by at least three (3) AIA Hong Kong Architect members in good standing
